GUIDELINES TO VISITORS

1. A list of names and age of the visitors (including staff members of the Institutions) should be submitted in advance for issue of entry permit.
2. Visitors other than students/ staff members should not be included in the list.
3. Foreigners are not allowed to visit this Station unless specifically permitted by us.
4. Visit of any College will be permitted only once in a year.
5. Children below the age of 16 years and pregnant women will not be permitted within this Station.
6. Visitors will be allowed on all working days.
7. Cameras, Cell Phones, Transistors, Pen Drives, Cell Phone chargers, Head Phone, CDs and other electronic equipments brought by the visitors should be deposited with the Duty Officer at the CISF Main Gate and collected after the visit. Electronic items are strictly prohibited and normally should not be brought during the visit. Visitors are advised not to bring any bag.
8. Transport facility, lodging facility for the visitors will not be provided.
9. Working lunch will be provided to all the visitors by MAPS.
10. This Station will not be responsible for any injury, accident or disability sustained by the visitors during the visit.
11. Visitors will have to abide by the security regulations of the Power Station. Students of Educational Institutions/Colleges should maintain perfect discipline inside the Station.

16. Only on receipt of valid entry permit, they should plan their visit to this Station.
